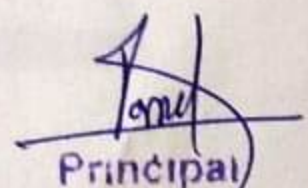

Objectives

The Finance Committee provides advice for purchasing, and oversight of the college Audit, budget. The responsibility of the committee is to operate financial matters transparently. Functions:

- 1) To prepare & consider Budget estimates and place before College Development Committee.
- 2) Responsible Committee for Audit.
- 3) To consider income from fees and other sources etc.
- 4) To recommend fixation/revision of fees and other charges payable by the students to the College.
- 5) The Finance Committee shall recommend the rates of remuneration & honorarium to various persons working in the college.
- 6) The expenditure other than provided in the budget shall be finalized by FC.
- 7) To consider all proposals for new expenditure and to make recommendations to Governing body.
- 8) FC shall scrutinize the accounts of the college and be responsible for audit compliance.
